

## TERMS & CONDITIONS OF AWARDS

1. Definitions

In these Terms & Conditions, the following definitions apply:

'Awards' means 'Marine Fuels 360'

'Awards Dinner' means the gala dinner to be held on 29 November 2023

'Entrant' means Awards entrant (including attendees at the Awards Dinner)

'Informa' means Singapore Exhibition Services (Pte) Ltd

- 2. By entering the Awards, the Entrant will be deemed to have read and understood these terms and conditions and be bound by them.
- 3. The Awards are open to international companies of the shipping, maritime services, bunker fuel suppliers and traders, energy companies, classification societies industries, as well as companies offering bespoke digital and technology solutions.
- 4. All entries must be received by Informa prior to the <u>submission deadline of 22 August 2023</u>. Entries received after the submission deadline will not be accepted.
- 5. All entries must be submitted in English, electronically via the dedicated submission platform with supporting documents (if applicable) using the 'Entry Form'. Any entry received by any other means will not be accepted.
- 6. Once submitted, entries are irrevocable and may not be withdrawn by the Entrant.
- 7. Entrants may enter up to three (3) award categories, however all submitted entries must be tailored for each individual category.
- 8. Entries must not exceed the word count of 150 words per section on the submission form. This word limit does not apply to supporting documentation.
- 9. Entrants agree that they will not upload and / or distribute any document in their submission for an Award which is confidential, defamatory, obscene, breaking personal privacy regulations, infringing copyright and intellectual property rights, violating legal rights of any party or proprietary to a brand, an individual or a company (except for the person submitting the work in his/her/their name). Informa reserves the right to delete any offending material and remove the entries from the Awards.
- 10. All Entrants agree to allow the details of their entry to be shared with the judges and representatives of Informa. All Entrants will be deemed to have consented to the transfer and sharing of their personal, company and project data and information for the purpose of administration and judging of the Awards and any other purposes to which the Entrant has

- 11. The Awards are judged by a panel of independent judges without the interference or influence of Informa or any Informa representative. The judges and Informa reserve the right at their absolute discretion to disqualify any entry (i) not accompanied by the appropriate supporting documentation, and/or (ii) deemed to be incomplete, inaccurate, false or misleading.
- 12. The judges' decision will be final and no explanation, correspondence or discussion will be offered or entered into before or following the judges' decision. Feedback will not be given on any entry before or following the judges' decision.
- 13. Should entries of a winning standard not been submitted into an individual category, the judges at their absolute discretion may decline to award a winner or finalists. The judges and Informa reserve the right to amend category selections where it is deemed appropriate.
- 14. All category finalists will be notified via-email on or about 5<sup>th</sup> October 2023. Finalists may also be listed on Informa's event website, social media and in marketing communications.
- 15. Winners will be announced during the Awards Dinner at Marina Bay Sands, Singapore, Sands Expo and Convention Centre. A winner will be announced from the finalists in each category with category winners receiving a trophy and a physical certificate. Finalists (excluding winners) will receive an e-certificate within 30 days of the Awards Dinner.
- 16. Finalists are not provided with complimentary tickets to the Awards Dinner and must purchase their own tickets to attend. All category finalists are strongly encouraged to be present at the Awards Dinner. Entrants will be solely responsible for obtaining any visas or permits to Singapore to attend the Awards Dinner.
- 17. The judges and Informa accept no responsibility for any costs and expenses associated with entering the Awards or attending the Awards Dinner.
- 18. Informa reserves the right at its absolute discretion to alter or reschedule the Awards, the Awards Dinner and / or to change the judging panel and / or these Terms & Conditions at any time and without notice.
- 19. Entrants expressly assume all risks associated with, resulting from or arising in connection with participation in and/or attendance at the Awards Dinner. All indemnities, warranties, representations, terms and conditions (whether express or implied) except as set out herein and/or as may be otherwise expressly advised are hereby excluded. Informa and all entities within the Informa Group (as well as any employees or other representatives of the same) exclude all liability for any loss, injury, disease or damage whatsoever that you may suffer in connection with or arising from the Awards and/or Awards Dinner whether direct, indirect, consequential, special, incidental or punitive loss, injury or damage (including, without limitation, injury or disease to persons, property damage, theft, loss of profits, loss of business, loss of opportunity, loss of goodwill, loss or corruption of data or any other type of economic loss, injury or damage) or otherwise. The limitations and exclusions in this paragraph only apply to the extent permitted by applicable law.

- 20. All Entrants agree to indemnify Informa against all costs, claims, damages and expenses that Informa may suffer or incur as a result of, or in connection with, any breach of these Terms & Conditions.

All Entrants grant Informa a non-exclusive, royalty free, irrevocable, worldwide license to use and reproduce (i) all content by them for the Awards, (ii) all images, videos and other media recorded by Informa or its representatives at the Awards Dinner, and (iii) their name, trademark and company logo, in each case for the marketing and promotion of the Awards, and for the commercial promotion of Informa and any Informa event.
- 22. Photography and filming by Informa's representatives will take place during the Awards Dinner. All attendees acknowledge and accept that Informa may record, photograph, film and broadcast (via print, electronic means and internet) any image or film footage taken during the Awards Dinner.
- 23. All winners and finalists of the Awards will be given the right to display the appropriate Awards winner and finalist logo on their websites and corporate marketing materials for their own promotion. Entrants may only use the official logo in connection with the Award category which they have won or have been announced as a finalist. The logo must be issued by Informa, must not be altered, and the year of the Award clearly displayed.
- 24. These Terms and Conditions shall be governed by, and construed in accordance with, the laws of Singapore and all disputes hereunder shall be submitted to the exclusive jurisdiction of the Singapore courts.
